### ***" NLE grant payments***

*We will start processing National Leader of Education (NLE) grant payments in October 2019.*

*These payments include the 18/19 School Improvement offer and claims for deployments outside the SI offer that you have told us about (there was a survey in an email circulated on 12 September - FAQs attached).*

*If your school has queried your grant payment, we will communicate any amendments in due course.*

*Any questions not answered by the attached FAQs should be directed to [school.improvement@education.gov.uk](mailto:school.improvement@education.gov.uk)*

### ***Teaching school hubs test and learn – review of system leadership***

*Assessment of applications is underway and we will announce successful test and learn teaching school hubs in due course.*

*Test and learn delivery is anticipated to commence in January 2020 and while this phase runs, **we will fund all teaching schools until at least September 2020**. To align payments to financial years, they will receive the first payment of £26,000 in Oct/Nov to cover the Autumn and Spring term of AY19/20; and another payment in April. All Department for Education (DfE) funding beyond FY19-20 is subject to confirmation. "*

The updated NLE grant payment FAQs are also detailed within the System Leader Newsletter and detail payment details for any of your 3 day deployments - [NLE Grant Payment FAQs](#). Extracts below detail some key aspects:

***" Q. When will my school be paid for the 3-day deployment/s that I have completed?***

***A. If you have received an email providing you with a breakdown of funds to be paid, or a link to the survey, we will begin processing payments in October 2019. This will include the claims for deployments completed outside of the SI offer, claimed via the survey.***

***However, if you have received an email indicating that your school's 2018-19 Collaborative Fund Evaluation/Collaborative Fund Annex G Assurance: 2017-18 and/or 2018-19 return has not yet been successfully evaluated payments will be placed 'on hold' until the successful evaluation of the return. "***
