

# **Governance structure and remit**

Achieving excellence together

Governance at Great Heights Academy Trust and its MAT schools is informed at all times by the latest version of DfE's Governance Handbook and Competency Framework; and complies with ESFA's Academies Financial Handbook, as updated.

Our governance structures and people involved currently are summarised below, with Trustee 'pen pictures' (areas of expertise/specialism) in an accompanying document.

The MAT Board (comprising ten "Trustees") are directors of the company and trustees of the exempt charity. The Chair of the MAT leads the Board, manages the business, provides leadership (alongside the CEO) for the MAT as a whole and is accountable for the vision, supporting the CEO when the MAT is held to account. The Trust also has five "Members" who have 'eyes on, hands off' roles, similar to shareholders of a business. Members take the lead in filling any vacancies on the Board, referring to the Competency Framework and skills gaps (procurement, communications, legal etc).

The levels of delegation (top down) are:

Level 1: Board of Trustees

Level 2: Chief Executive Officer

Level 3: Academy Principal / Head of Designation

Level 4: Academy Council (LGB)

#### LGBs – Greetland, West Vale, Raynville, Carlinghow & Bowling Green Academy

Local Governing Bodies (LGBs) have been formed according to a bespoke version of the NGA scheme of delegation (Model 2\*\*, Version 2): 'Academy Council', with powers only to advise and recommend, not decide. Parents (Parent Local Governors) are elected at the LGB level, i.e. not to the MAT Board. Academy Council memberships are subject to ongoing review and skills audit.

The Board of Trustees manages the business and exercises all the powers of the Academy Trust."

#### Background

Proposals for MAT governance structures, roles, responsibilities and accountabilities were initially set out in a 'pitch' booklet 2015/16. The inaugural meeting of the Trust's MAT Board was held on 25<sup>th</sup> January 2018 (minutes available on the <u>MAT website</u>).

The Trust re-branded to 'Great Heights Academy Trust' in Summer 2020.
